

Los Angeles City Planning has drafted an ordinance expanding the regulations the City can activate during a declared local emergency. These regulations will complement current provisions in the Zoning Code that provide relief and flexibility to respond and recover from a local emergency. The provisions generally provide relief from time limitations for certain approvals and for certain parking requirements for businesses and nonresidential uses.

Note: The officers themselves must see the crime being committed. They will not make an arrest based on your photographs or videos.

If you have a long-term issue that a patrol car cannot handle. An ongoing business, property or neighbor situation or dispute:

Please contact the Senior Lead Officer for our area; Jose Saldana. Cell: 1-818-731-2565 Station: 1-818-374-9500 or e-mail him at <u>30853@lapd.online</u>.

Note: He does not take police reports.

If you see someone experiencing homelessness, struggling with their physical and/or mental health issues:

Please submit an LA HOP request to the LAHSA – Los Angeles Homeless Outreach Portal <u>https://www.lahsa.org/portal/apps/la-hop/request</u> or by calling 211.

For trash or debris in the BID:

Please contact our Street plus supervisor, Alex Duran at 1-213-713-5614 or e-mail him at <u>ADuran@streetplus.net</u> and he will send over a day–porter.

Graffiti Removal:

File a 311 request at <u>https://www.lacity.org/myla311</u> or on the MyLA311 App.or call 311.

To remove unwanted persons from private property:

Post a no trespassing sign (see example below). You must ensure proper signage has been posted in accordance with Los Angeles Municipal Code Section 41.24 (a) AND file a *Trespass Arrest Authorization Form* with the LAPD. Please keep a copy for yourself.

I am the Owner/Owner's agent/person in lawful possession of the above referenced property. I request and authorize the Los Angeles Police Department to enter the above property and enforce Los Angeles Municipal Code 41.24.

#### [CHECK APPLICABLE PARAGRAPH(S)]

Posted property not open to the general public, L.A.M.C. Section 41.24 (a)

My property has been posted in accordance with L.A.M.C. 41.24(f) with signs stating "THIS PROPERTY CLOSED TO THE PUBLIC. No Entry Without Permission. L.A.M.C. SEC. 41.24." I authorize the Los Angeles Police Department to arrest anyone on my property who is not a lawful resident, guest or visitor and not exempted under L.A.M.C. 41.24(h) for a violation of L.A.M.C. 41.24(a).

#### Posted or unposted property not open to the general public, L.A.M.C. Section 41.24 (b)

I authorize the Los Angeles Police Department, pursuant to L.A.M.C. 41.24(b) to advise persons who are not lawful residents, guest, visitors, and not exempted under L.A.M.C. 41.24(h) to leave my property and not to return for 6 months and to arrest such person if they return within six months for a violation of L.A.M.C. 41.24(b)

#### Commercial property open to the general public, L.A.M.C. Section 41.24 (d)

My property is open to the general public between the hours of \_\_\_\_\_\_ to \_\_\_\_\_. I authorize the Los Angeles Police Department to advise persons pursuant to L.A.M.C. 41.24(d) to leave the premises for 24 hours if the request to leave is rationally related to the services performed or the facilities provided on the property. I further authorize the Los Angeles Police Department to arrest anyone who has been so notified and refuses to leave or returns within 24 hours for a violation of L.A.M.C. 41.24(d).
