

Press Release: Councilman Ryu's Permanent Al Fresco Legislation Moves Forward

The Los Angeles City Council's Transportation Committee today approved Councilmember David Ryu's motion seeking to implement a permanent version of the city's Al Fresco program, sending it to full Council for a vote. The Al Fresco Program, which has received positive feedback from restaurants, diners and restaurant adjacent neighborhoods, supports the heavily impacted restaurant industry by allowing restaurants to operate outdoors. The motion approved today in Committee seeks a report back on the feasibility of making this program permanent.

The highly regarded Sherman Oaks Chamber Foundation, www.letspaintshermanoaks.com, which is responsible for the lovely painted utility boxes in the BID and throughout Sherman Oaks, has offered the BID the opportunity to have art in vacant windows at no cost to the property owners. This has been a very successful program in other areas, including Tarzana and Beverly Hills, bringing a sense of vibrancy to an otherwise vacant storefront. It has the potential to make the storefronts easier to lease and possibly less attractive to transients who may not realize they are vacant. Rather than drab brown paper or nothing in the windows, art can transform the space into something that looks appealing, inviting and cared about.
